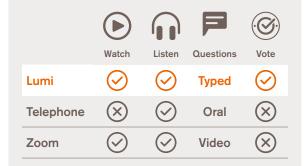

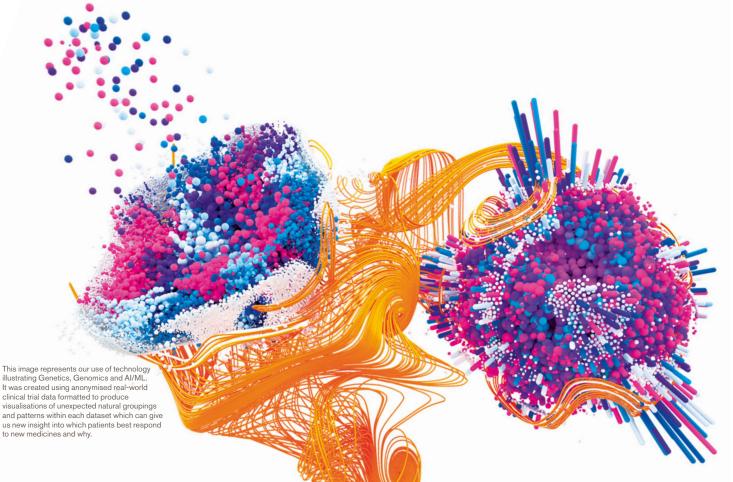
How to join
